Called to order: 7:00 PM **Attendance:** Approximately 50+

President's Report: Newly elected MVCC Board of Directors responded to Martin's invitation to attend, and for the first fifteen minutes of the meeting they briefly introduced themselves. He then mentioned that our 6th annual Fall Block Party would take place on Saturday, September 21 from 3 P.M. in Saint Andrew's parking lot.

Guest speaker: 7:15 PM NWNA President **Martin Rubin** introduced Councilmember **Mike Bonin**. Mr. Bonin gave a twenty-minute Power Point presentation. Martin planned to take the microphone around to neighbors for questions.

Mr. Bonin was scheduled to leave at 8 PM, but he stayed another 10 minutes to speak on the homeless situation. After Councilman Bonin left, Martin opened up the floor to MVCC board members who wanted to talk about MVCC committees. Many in the audience stayed until the meeting was adjourned. I suggested to Martin that at future meetings, he should announce the format of the meeting on an agenda to avoid any confusion.
